



MEMORIAL & COMMEMORATIVE STONES

RESERVED PLACEMENTS

The Corps Memorial Garden's (CMG) new block paving in late-2009 enabled the establishment of individual Memorial and Commemorative Stones in the pathway. The Memorial Stones – see the separate Flyer and Order form (CMG Form 1) - may be ordered by anyone who wishes to commemorate a *bona fide* Corps individual, unit or event. The Stones are manufactured in honed light grey granite with black lettering. As an additional service, it is now possible to reserve a place – anonymously - in the CMG, perhaps with a family member, within a group of former friends or colleagues, or with a particular unit commemorative grouping. A Certificate of Reservation will be issued to each customer, which will reflect the person in whose name the place is being reserved or the consignor.

For Reserving an individual place in a particular area or group of stones:

- 200mm x 100mm x 30mm (8in x 4 in x 1.2in), chamfered edges.
- Text to read (eg): **“RESERVED PLACEMENT No 1942”** (anonymous, registered date)
- Replaces a single standard block paver stone.

Price = £70.00 incl VAT

ORDER PROCESS

The Reserved Placement will be marked by a standard granite stone as shown above, but with an ascending year-date from 1942. They may be ordered at any time but, since the stones will be manufactured to order in batches (of all styles), no guarantee may be given as to when they will be produced or laid. However, every effort will be made to expedite their manufacture and installation in the relevant CMG pathway. All orders will be acknowledged and each installation will be notified to the individual making the order. Replacement of the Reserved stone, at the appropriate time and with the specific text, will be actioned upon receipt of the formal order for an Individual Memorial Stone (see separate Memorial Stone Order Form, CMG Form 1). We regret that pre-ordering of the Memorial Stone linked to the Reserved Placement cannot be accepted.

PAYMENT

Payment should be ideally be made by Bank Transfer; (BACS); details of the required Account will be notified upon receipt of the Order Form: Alternatively, payment may be made by cheque at the time of the order, payable to 'The Centurion Fund (CMG)' and sent to the address shown on the form.

TERMS & CONDITIONS

Orders will not be processed until the full payment is received. Cheques will be submitted for payment upon receipt. No responsibility will be taken by the Corps or its representatives for errors contained in the original order form submitted and customers are urged to check their orders carefully before submission. Orders may be cancelled without penalty up until it is passed to the manufacturer; thereafter, the order will be deemed irreversible and refunds will not be possible. Only badged members of the RAF Regiment and their antecedent RAF Armoured Car Company and Ground Gunner organisations may be so honoured. The stones will follow a standardised design and variations will not be permitted. 'Reserved Placement' stones will reflect just a Reserved number (an ascending year-date from 1942) and ownership will be retained by the CMG Executive Council (Exco). The placement of the Stones within the Garden will be at the CMG's Exco's discretion and no guarantee may be given as to when they will be laid. Subsequent Individual Memorial Stones will be produced in accordance with the relevant policy and style at the time of ordering. Customers are encouraged to keep a copy of their order(s) in case of any issues arising. All prices are inclusive of installation and applicable taxes. Prices may change at any time to reflect changing costs. All orders will be acknowledged and confirmation will be given when the Stones are commissioned and then laid. E&OE.
